Therefore, the Court finds that the Plaintiffs' Motions for Summary Judgment are granted, and the Defendants' Motions for Summary Judgment are denied.

JUDGMENT is entered for the Plaintiffs and against the Defendants as follows;

Plaintiffs are awarded judgment against Continental Casualty Company in the amount of \$1,000,000.00

Plaintiffs are awarded judgment against Great American Insurance Company in the amount of \$10,000,000.00

Plaintiffs are awarded Judgment against Zurich American Insurance Company in the amount of \$92,000,000.00

Plaintiffs are awarded judgment against The North River Insurance Company in the amount of \$10,000,000.00

Plaintiffs are awarded judgment against Philadelphia Indemnity Insurance Company in the amount of \$232,000,000.00

Each Judgment shall bear interest pursuant to O.C.G.A. section 7-4-12(a) from the 15 April 2024.

All other paragraphs of the Courts Order of April 15, 2024 remain in full force and effect.
